

SUBJECT OF RESOLUTION: Measures to Eliminate International Terrorism

The Sixth Assembly

1 *Recalling* the Definition of Aggression, the Declaration on the Enhancement of the Effectiveness
2 of the Principle of Refraining from the Threat of Use of Force in International Relations and the
3 International Covenant on Civil and Political Rights, and A/RES/55/158,

4 *Further recalling* Security Council Resolution 1269 of 19 October 1999, 1368 of 12 December
5 2001, 1373 of 28 September 2001, and 1440 of 24 October 2002,

6 *Deeply disturbed* by the world wide persistence of acts of international terrorism in all forms and
7 manifestations,

8 *Convinced* of the desirability for closer coordination and cooperation among States in combating
9 international terrorism and bearing in mind the role that could be played by both the United
10 Nations and regional organizations,

11 *Emphasizing* the importance of Member States taking a multi-lateral approach to the issue of
12 international terrorism.

13 *Recognizing* that each region's terrorist issues often stem from a unique set of economical,
14 political, and social issues.

15 *Firmly determined* to eliminate international terrorism in all its forms and manifestations,

16 1. *Unequivocally condemns* in the strongest terms all forms and manifestations of terrorism
17 that have taken place around the world and regard such acts, like any act of international
18 terrorism, as a threat to international peace and security;

19 2. *Strongly urges* all States to recognize the sanctity of all religions, races, cultures,
20 ethnicity, which has no relation to any form, and manifestation of international terrorism;

- 21 3. *Welcomes* all States to redirect their efforts in finding the roots and causes of terrorism
22 which are the breeding grounds for terrorist;
- 23 4. *Solemnly reaffirms* their unequivocal condemnation of all acts, methods, and practices of
24 terrorism as criminal and unjustified, including those which threaten the territorial
25 integrity, peace and security of the world community;
- 26 5. *Strongly encourages* the international community to enhance cooperation in the areas of
27 intelligence, border control, dismantling of terrorist financial networks, and enhanced
28 security in transportation systems, while maintaining and preserving the mandate of
29 Article 2, Section 1, of the UN Charter
- 30 6. *Further encourages* States to cooperate and strengthen existing regional anti-terrorist
31 efforts;
- 32 7. *Urges* an initiative for closer cooperation between UN and non-UN territories, focusing
33 on regional cooperation and problem solving;
- 34 8. *Emphasizing* that state sovereignty is preeminent, therefore, all preventive and
35 reactionary actions pertaining to terrorism be conducted with the integrity of state
36 sovereignty and regional interests as a priority.
