The General Assembly

- 1 *Reaffirming* the goals of the United Nations Assistance Mission in Afghanistan
2 (UNAMA),
3
4 *Guided by* the United Nations Declaration of Human Rights, particularly Article
5 26,
6
7 *Recognizing* the sovereignty and cultural integrity of Afghanistan as well as
8 promoting the individual liberties as laid out in the Afghanistan Constitution,
9
10 *Further recognizing* the progress begun in implementing and developing
11 educational programs, while nonetheless remaining committed to the progress of
12 education as an essential element to social, economic, cultural, and political development,
13
14 *Convinced* that continued collaboration between the international community and
15 Afghanistan is needed in pursuing efficient and affordable education institutions in both
16 urban and rural areas in order to provide equitable distribution of infrastructure,
17 resources, faculty, and community support,
18
19 *Acknowledging* the overall young age of Afghanistan's population and its
20 relevance to the importance of education throughout the country,
21
22 1. *Supports* the efforts of Afghanistan to continue to take an essential role in
23 developing and implementing educational programs within its borders;

25 2. *Recommends* continued collaborative efforts between the Government of
26 Afghanistan and the United Nations in order to create a better environment more suitable
27 for universal education;

29 3. *Supports* an increase in the number of UNAMA personnel to best ensure
30 widespread implementation of educational programs:

- 32 4. *Calls upon* Member States to pledge further resources toward the aid for
33 educational opportunity, including but not limited to:
34 (a) Scholarships offered for higher education and study abroad
35 program to United Nations Member States;
36 (b) Provide training and education of Afghani nationals to be
37 teachers capable of sustaining the education system;

- 39 5. *Further recommends* restructuring of educational programs specifically to:
40 (a) Provide vocational training;
41 (b) Support efforts to promote the development of higher education
42 opportunities for highly skilled professional trades;

- 44 6. *Supports* the need to increase educational infrastructure in order to improve
45 overall educational and economic standing in the country, particularly through the
46 construction of new school facilities in rural areas and the proper outfitting of these
47 schools;

- 49 7. *Recommends* a focus on training within the national government, particularly
50 of judges, magistrates, lawyers, and especially the national police force as a way to
51 strengthen personnel infrastructure within Afghanistan’s government;

- 53 8. *Calls upon* all Afghanistan Security Forces to immediately work to stem the
54 flow of recent violent attacks against students and therefore guarantee their right to
55 education and training.
