Criminal Accountability of United Nations Officials

and Experts on Mission SUBMITTED TO: The Sixth Committee SUBMITTED BY: China, Peoples Republic of Korea, Indonesia, Malaysia, Mongolia, Thailand, Viet Nam The Sixth Committee Recognizing the existing efforts of the United Nations in resolution A/63/437 in endorsing a legal committee providing advice on how best to support the original intent of the United Nations Charter, Aware of the widespread criminal and sexual abuse of civilians conducted by United Nations officials in areas under United Nations influence, Reaffirming the need to emphasize the respect for international law by United Nations officials on missions. Taking into consideration the devotion that the United Nations has shown to the topic of international humanitarian law, Having examined the inability of the preexisting Ad Hoc committee to absolutely ensure all cases of criminal and sexual abuse are reported, 1. Recommends the establishment of independent, mission based Ombudsman's Oversight Offices, which would be empowered to conduct their own inquiries into allegations of abuse by UN officers, such offices will have the following functions: (a) Make both private and public recommendations to UN Member states on the scope of immunity, the existence of a duty to waive immunity and the suitability of prosecution: (b) Provide victims with an appropriate recourse, ensuring that the victim's individual rights are protected in an impartial environment: (c) Establish an office specifically for complaints and reports of crimes committed by UN workers; (d) Create a database containing information about the types of crimes; committed

as well as the location of the crime, granting confidentially to perpetrators;

(e) Ensure that the anonymity of the victim is respected;

9. *Strongly encourages* all nations to focus on preventative measures as a long-term solution to eradicate criminal and sexual abuse of civilians in the areas under United Nations influence.
