The General Assembly Third Committee

Recalling the statement on sexual violence made by Ban Ki-Moon, who said: "Like
grenade or a gun, sexual violence is a part of their arsenal to pursue military, political, social, and
economic aims. The perpetrators generally operate with impunity,"

Acknowledging the commitments made by ninety-eight states having voluntarily adopted the Convention on the Elimination of All Forms of Discrimination Against Women (1979),

8 *Reaffirming* its commitment to Resolutions 1325 (2000), 1612 (2005), 1674 (2006), 1820 9 (2008), 1882 (2009), and 1888 (2009) and the relevant language therein, 10

Noting the two reports of the Secretary-General, published on 2 August 2010, concerning
the intensification of efforts to eliminate violence against women and trafficking in women and
girls,

Noting with concern the limited progress that has been made thus far, as evident by
Secretary-General reports A/65/208 (2010) and A/65/2009 (2010), in the global effort to
eliminate rape and other forms of sexual violence in all their manifestations,

19 *Emphasizing* the importance of education as a catalyst to both economic and social
20 development,

Calling upon the international community to maintain current North-South and South South cooperative efforts while also establishing new agreements with states in an effort to
encourage international development cooperation,

Encourages large-scale, collaborative and multilateral cooperation in the interest of
achieving the common goal of eliminating rape and other forms of sexual violence in all their
manifestations;

2. *Calls upon* both developed and developing states to engage in North-South, South South, and Triangular development assistance programs or agreements with the common goal of
establishing educational facilities and programs that will be instrumental in the elimination of
sexual violence towards both men and women;

Stresses the importance of education in the elimination of rape and sexual violence, 36 with particular emphasis on: 37 (a) Community and leadership education based upon individual state interests; 38 (b) Availability and especially access to educational opportunities, whether through 39 economic initiatives, transportation efforts, or social mobility; 40 (c) Advocacy and preventative efforts that not only address current levels of sexual 41 violence but also work to diminish and prevent future occurrences of rape and all other 42 forms of sexual violence; 43 44 4. Calls upon individual states to utilize Non-Governmental Organizations, both 45 domestic and international, with particular emphasis on the micro-level track-two diplomacy; 46 47 5. Encourages Non-Governmental Organizations to focus their efforts on short-term, 48 immediate progress through working directly with victims of sexual violence, regardless of 49 gender, and encouraging societal reintegration efforts involving victims of sexual violence 50 through efforts such as: 51 (a) Non-Governmental Organizations providing technical and logistical advice to 52 government organizations; 53 (b) Non-Governmental Organizations providing volunteers, who have been trained to 54 respect regional and cultural norms of the target region, to help implement education and 55 awareness campaigns concerning sexual violence as well as providing medical and counseling services to victims: 56 57 58 6. Welcomes the use of preexisting frameworks and Non-Governmental Organizations to 59 implement these programs, and also looking into the creation of further organizations if deemed 60 necessary; 61 62 7. *Requests* that State governments fulfill a leadership role and serve as a primary driving 63 force behind change and they serve in an administrative and oversight role over any 64 implementation of said policies while maintaining focus on long-term and sustainable efforts 65 rather than immediate, short-term efforts; 66 67 8. Encourages the use of bilateral subsidies to promote utilization of current and future 68 education opportunities and facilities, and in particular recommends the implementation of 69 subsidies to impoverished families with school-age children.
