Top 8 Breaking News for the UN 1973: A Busy Year

Representatives in the Histori-L cal Security Council (1973) from the United States, USSR, China and France have been incredibly busy observing world security. During a press conference Monday morning they addressed peace talks in the Middle East and an American/Soviet coalition in Cyprus. The Council also announced the addition of three new Member States.

Russians in Iranian Reactors

2 Iran has recently allowed professionals from the Russian Federation and India into many, if not all, nuclear facilities. The Russian Federation and India declared that any and all potentially dangerous materials are being used solely for domestic, industrial and educational use.

Greek Financial Woes

 $3^{\hbox{Greece held a press conference}}_{\hbox{Monday morning to address mul-}}$ tiple issues in the ECE. Its representatives voiced their concerns about their litigation being ignored because of their current financial state. They also brought attention to the help they were receiving from Hungary and Poland, and suggested nuclear arms could be a deterrent to war with Turkey.

Developing Microcredit

A Press Conference was held by representatives of Cuba, Ghana and Tunisia on the subject of microcredit in developing nations. The focus of Resolution 2/I/3 was centered on linking available aid to the 48 least-developed nations to improve quality of life for impoverished citizens. Additionally, Resolution 2/I/4 was passed during the conference, focusing on educational needs for recipients of microcredit.

Russia Issues Condemnation

 $5^{\rm The~Russian~Federation~condemns~the~US~for~acting~unilater}$ ally in the invasion of Iraq, despite Security Council resolutions urging the United States to pursue a more peaceful means of intervention. The Russian Federation maintains that the US invasion of Iraq was hypocritical and inappropriate in light of lacking international cooperation.

France is Against Irag Invasion

France held a press conference 6 Monday morning to condemn the bilateral invasion of Iraq by the United States and the United Kingdom. The representatives from France explained that they are currently acting as mediators to maintain peace and collaboration, as stated in the UN charter.

ICJ Verdict in Germany v. Italy

7 Nine justices wrote and signed the majority opinion ruling in favor of Germany. Justice Kron, who was concerned with the ruling, penned an opinion of his own. Justices Berman and Hathaway dissented.

UK Mission Shot Down

8 On 21 November 2011, the UK sent a special operation into Syrian territory in order to bring Minister al-Sari to safety. The mission was shot down, with sixteen presumed dead and two captured. The UK now considers Syria to be a hostile state.

Committee Updates: Work of the United Nations Never Stops

The contemporary Security Council passed a resolution on Monday morning regarding Iranian nuclear weaponry. SC/I/3 calls for economic sanctions unless transparency within Iran is dramatically increased. The resolution was passed with a vote of 11/1/3. Brazil voted against the resolution due to concerns voiced by Representative Greg Siems of Brazil: "[Economic] sanctions will only antagonize and isolate Iran and will merely escalate the situation."

The General Assembly Plenary has been working quickly, perhaps too quickly according to some concerned representatives. As of noon on Monday, the committee has voted on five resolutions, accepting three out of the

Representative Fiona Meeker of Ecuador voiced her concern about the sense of haste among the representatives. She urged the GA to be more considerate, as they had previously passed three resolutions with little discussion.

Many representatives believe that this sense of haste is greatly influencing the actions being taken by the GA. Representative Ryan Donovan of Haiti, a sponsor of GA Plen/I/7, believed the resolution was one of the most innovative solutions to drug reform. The resolution ultimately failed by a vote of 22/38/36. Unfortunately, there was not adequate time given for debate or discussion of possible amendments, which is why Haiti feels GA Plen/I/7 failed.

Representatives in the First Committee were able to collectively overcome the deadlock that has existed since Sunday night by passing two resolutions. The first resolution, 1st/II/2, which was an effort to coordinate the destruction of illicit stockpiles of small arms and light weapons and to eliminate the illicit trafficking of these weapons, passed with a vote of 40/30/26 early Monday morning. Shortly thereafter, the committee was able to overwhelmingly pass Resolution 1st/II/5, which seeks to assist in the removal of landmines in post-conflict areas and rehabilitate victims of injuries resulting from landmines, with a vote of 83/4/10. The First Committee is continuing debate on Resolution 1st/II/6, a resolution that focuses on disarming, demobilizing and reintegrating combatants, with two amendments already approved. Expectations are high following this very productive Monday morning.

On Monday, discussion began in the General Assembly Second Committee on the issue of renewable energy, switching topics from the previous debate on Microfinance and Microcredit. Resolution 2nd/II/1 has been distributed to representatives for discussion, and the proposed resolution is being heatedly debated in session. The main cause of concern in the resolution is the proposal for the creation of an Intergovernmental Organization (IGO) that will organize regional boards of representatives for the purpose of distributing aid to nations looking to expand their renewable energy operations. Resolutions 2nd/II/2 and 2nd/II/3 have also been produced, though they have not yet been brought up for discussion.

The Third Committee passed another resolution regarding the Right to Food topic area in Monday morning's session. After a division of the question, Resolution 3rd/I/8 passed without clause 6 by a vote of 79/6/16. Thereafter, the assembly switched to the second agenda topic, Protecting Human Rights and Fundamental Freedoms While Countering Terrorism, by a vote of 58/27/10. The initial discussion addressed the mutual relationship between human rights and countering ter-

Representative Ifedayo Olasupo of Djibouti said he was very disappointed with the way committee went this morning. As a whole, the committee is failing to reach consensus, and Representative Olasupo said that he believes this is the most important goal of the committee. Throughout the entirety of the morning only a few items were passed. Along with the vetos of draft resolutions, there was a vote of no competence and two roll call votes, in addition to appeals of the decisions of the chairs, re-votes, and many more motions that were thwarted during this morning's session.

The Commission on Sustainable Development continues to make progress toward sustainable development, passing two more resolutions Monday morning. Resolution CSD/I/3 was adopted by consensus with no abstentions. It addresses issues from the International Subcommittee. An amendment known as "More Radios" was added by a vote of 25/2/7. The CSD also passed Resolution CSD/I/5 by a vote of 30/2/2. It addresses issues from the Education Subcommittee. Draft Resolution CSD/I/1 was also brought back to the floor, causing a heated debate that still continues.

The Economic Commission for Europe continues to debate the issue of clean and renewable energy as of Monday night. It completed the first draft of a report on possible plans to deal with global carbon emissions. This report deals with three various methods of limiting carbon pollution: study of the EU Emission Trad-

ing System, a proposed carbon tax and research on Land Value Taxation and International Monetary Commitments. Each of these methods are reviewed in detail in the report and are analyzed based on various characteristics, such as feasibility and incentives produced for countries. More news on this will follow as discussion continues on the report.

The Economic and Social Council passed Resolution ECOSOC/ II/1 on Monday morning by a vote of 35/1/6. The resolution is expected to open negotiations between Israel and Palestine by allowing businesses to develop using basic materials to run an economy. The resolution encourages small, peaceful negotiations between the two nations. Those who did not support the resolution were members of the Arab League and voiced concerns in recognizing Israel as an official nation, as the resolution calls for. Japan was one of the primary supporters of the resolution. Representative Joel McGuire of Japan thinks the resolution is a big step in the right direction for Israel and Palestine relations."It's a neutral agreement that is going to be beneficial for everybody and creates economic development for Palestine by increasing trade, assuming the Security Council does not block it and if Israel accepts the resolution," he said.

The Historical Security Council of 1973, in an evident display of solidarity, passed resolution HCS-1973/I/4 Monday morning, by a vote of 14/1/0, with the outlier vote being the nation of Sudan. This resolution was passed in response to the "ongoing hostility on the southern border of Zambia," according to line five of the resolution.

The Security Council plans to maintain peace in the region by sending no more than 1,000

ground troops with small arms to Zambia's southern border. These troops will be deployed from the nations of Peru, Australia, and Indonesia, as well as any other Member State that volunteers.

This peacekeeping mission will last for approximately six months before it must be reevaluated and approved again by both the Security Council and Zambia.

The Historical Security Council of 2003 started Monday's discussion with an update from the International Red Crescent informing the Council that the Oil for Food Program no longer operates in Iraq, affecting 60% of the Iraqi population. France drafted Resolution HSC-2003/3 to address the humanitarian crisis in Iraq and proposed creating the United Nations Mission in Iraq (UNMI). The Syrian Arab Republic stated that it supports all humanitarian aid efforts in Iraq. Similarly, Representative Chris Gelke of Chile said "the success of HSC-2003/3 will ensure that the people of Iraq get the help they need." At press time, representatives were caucusing about draft resolution HSC-2003/4, which focused on the creation of an independent, self-governed Iraq.

The Concerns of the DPRK

The General Assembly Plenary Representatives from the Democratic Peoples Republic of Korea (DPRK) voiced their concern on Monday about topics being discussed at this conference, particularly in the GA Plenary.

Representatives Will Deyoung and Representative Madalyn Holyfield of DPRK felt that many of the topics being discussed are built upon Western states. They believe that many countries are incapable of addressing these so-called "first-world" problems. Representative Deyoung believes, "We are wasting our time on

issues that aren't relevant to all countries. We could use our time much better."

The particular topic being discussed heavily in GA Plenary that concerns these representatives is the International Cooperation Against the World Drug Problem. DPRK's stance on this topic is that the world drug problem is not a global problem.

Ultimately, this delegation is distraught because they feel that "these topics almost seem incapable to reach all people," said Representative Deyoung.

The Hellenic Republic would like to clarify statements made at our press conference earlier today. Greece is fully committed to the democratic and capitalistic principles of the European Union. We are committed to the principles of the EU. Greece is struggling through a period of political and economic instability. Rogue voices will sometimes lash out and blame the problems that Greece faces on others and will offer solutions that are unpractical and unethical. Greece wants the EU to know that we are committed to Europe as our future and will work towards as stronger Europe. Greece also refers to the Greek Permanent Representative for any further questions regarding today's press conference.
