Committee & Council Updates

GENERAL ASSEMBLY PLENARY

1 The General Assembly Concurrent Plenary submitted and debated drafts of resolutions and submitted two. The resolutions pertain to the development of preventative measures and the establishment of a cluster approach, respectively.

GA FIRST COMMITTEE

2 The Committee on Disarmament and International Security passed its first resolution on Sunday evening, which highlighted and reaffirmed the Non-Proliferation Treaty. Four other draft resolutions have been proposed.

GA SECOND COMMITTEE

3 The GA Second Committee passed a resolution concerning food security on Sunday evening by a vote of 68/19/15. The resolution advocates expanding agricultural education, as well as creating local food co-ops. The resolution was sponsored by Indonesia, Uzbekistan, Kazakhstan, Jamaica, Turkmenistan, Nepal and Sri Lanka.

GA THIRD COMMITTEE

4 The Third Committee has debated three resolutions. Resolution 3rd/I/1 failed. A consensus on resolution 3rd/I/2 was not reached. The committee had not discussed 3rd/I/3.

GA FOURTH COMMITTEE

5 During session Sunday night, the Fourth Committee passed Resolution 4th/I/1. This resolution involved refugees and promoted the international community coming together to help with the Occupation of the Syrian Golan.

HUMAN RIGHTS COUNCIL

6 The Human Rights Council has focused its attention on a number of topics relating to the rights of civilians in armed conflict. Specific topics include sexual violence against especially vulnerable groups, refugees, government accountability and the Palestinian/Israeli conflict.

ECOSOC

7 After a prolonged debate, the Economic and Social Council passed resolution ECOSOC/I/1. The body is currently discussing a resolution regarding education in a global market.

ESCAP

8 The Economic and Social Commission for Asia and the Pacific spent Sunday night writing reports in subgroups. Each subgroup focused on a different aspect of the issue of Energy Security and Sustainable Development.

CPD

9 The Commission on Population and Development passed a resolution regarding education. The commission moved on to writing a draft resolution regarding employment and its ties to migration.

ICJ DELIBERATES ON SECOND CASE CONGO V. UGANDA

The case will be decided Monday evening at 6:10 pm.

The International Court of Justice had a busy Sunday that consisted of announcing the opinion of its first case, as well as hearing its second. In the *Malaysia/Singapore* case, the Court decided for Malaysia, with nine justices in favor and seven dissenting.

The second case to be decided

by the ICJ is *Democratic Republic of the Congo v. Republic of Uganda*, which was heard on Sunday evening. The case revolved around unwanted military occupation of the Democratic Republic of the Congo (DRC) by Uganda.

Due to instability during regime change, the DRC requested aid from Uganda in maintaining control of the eastern Congo. The DRC charges that instead of simply providing the needed aid under reasonable circumstances, the Ugandan military refused to leave

the country upon request and unleashed a barrage of attacks on DRC civilians which included massacres, rape, abductions and looting.

The advocates of Uganda argued that the actions taken by Uganda were entirely humanitarian in nature and required to maintain stability in the region. Any attacks of such brutal nature, they insist, were instigated by paramilitary groups unaffiliated with any country.

The case will be decided Monday evening at 6:10 pm.

ESCAP FOCUSES ON REPORT WRITING

The Economic and Social Commission for Asia and the Pacific has spent the day splitting into informal subgroups to focus on report writing. Each group is writing a report about an aspect of energy security and sustainable development.

The different subgroups will focus on different aspects of the

overall topic, such as available and alternative energy forms, increasing and maintaining infrastructure, and resource sharing.

Representative Samantha Burt of Turkey, who sits on the commission, is working in a subgroup which is writing a report on alternative energy sources. Turkey hopes to include an emphasis on hydroelectric power.

Representative Burt said ESCAP had a slow start but is confident things will pick up. "There was a lot of argument regarding how to approach the topic but today we've made more progress as far as report writing goes," she said.

ESCAP plans to submit its reports to the Economic and Social Council in order to guide its resolutions.

ISRAEL AND SYRIA'S FAILED PEACE RESOLUTION

At the beginning of the AMUN conference, Syria began work on a conflict Resolution 4th/I/6, involving the eventual transfer of the Golan Heights region back to Syria. At first, Representatives from Israel supported the Resolution. "If you were given the Golan Heights on a silver platter, you would take it."

said Syrian Representative Abdul Abufilat. The resolution recommended dialogue between Member States rather than forcing the transfer of the territory. Many representatives had a great deal of concern with the resolution. After a day-and-a-half of work, representatives of Israel suddenly took away their support of the resolution, saying that they cannot sup-

port the actions of Syria again.

With strong opposition from multiple representatives, peace negotiations remained at a standstill. Such divisiveness in a committee makes it hard for draft proposals to be passed. As close as they had come to achieving a peaceful solution to the issue of the Syrian Golan through resolution, it was ultimately unsuccessful.

Security Council & ICJ Updates

CONTEMPORARY SECURITY COUNCIL

1 The Security Council passed resolution SC/3 with a vote of 13 in favor, none opposed and two abstentions. The resolution addressed the rebel groups in the Democratic Republic of the Congo by attempting to limit aid the groups receive from external sources.

HISTORICAL SECURITY COUNCIL '48

2 Representatives in the Historical Security Council of 1948 reached their limits on the issue of violence in Palestine. During one suspension of the meeting, representatives were yelling at one another from across the room. Soon after, the Council moved to the topic of Berlin.

HISTORICAL SECURITY COUNCIL '90

3 Two press conferences were held Sunday night regarding South Africa's recent invasion of the sovereign state of Namibia. This invasion was in response to Cuba's continued occupation and support of Angola.

INTERNATIONAL COURT OF JUSTICE

4 On Sunday evening the ICJ not only released opinions in the *Malaysia/Singapore* case, with nine votes in favor of Malaysia and seven in favor of Singapore. The ICJ also heard the case of *Democratic Republic of the Congo v. Republic of Uganda*, which involved unwanted military occupation of the DRC by Uganda.

GA PLEN GOES BACK & FORTH OVER RESOLUTIONS

The General Assembly Concurrent Plenary has submitted draft resolutions GA Plen/I/1 and GA Plen/I/2 and has discussed changes necessary for each draft. After some debate, authors of similar resolutions are working together to combine their drafts into one. "There was a lot of back and

forth over whether some resolutions should be combined," said Representative Lyndon Novotny of Germany. "Now we have five potential resolutions, and I think by the end of this evening we should have one passed."

Draft resolution GA Plen/I/1 addresses the cluster approach, the categorization of the nations into 11 bodies. Each of the bodies

would have a designated response team lead by a regional actor.

Draft resolution GA Plen/I/2 proposes the development of preventative measures such as vaccination and health screening programs to ensure the safety of aid workers and promote regional early warning systems, in an effort to decrease displacement caused by natural disasters.

WHY CAN'T WE BE FRIENDS: DUELING HSC PRESS CONFERENCES

Two concurrent press conferences Sunday night helped shed light and spark debate about the issue of Cuban troops occupying Angola and South Africa's subsequent invasion of Namibia in response.

Representatives from Cuba led the first conference, and they took this opportunity to announce that since South Africa had broken the New York accords with their invasion of Namibia, Cuba was no longer compelled to stay above the 13th parallel and have since moved troops to the Angolan border. The representatives maintained that this

is merely a precautionary measure and that they are not actively seek-

ing war; however, they were also quick to suggest strict sanctions on South Africa, most notably the revocation of all oil and arms sales from the global community.

Members of the Organization for African Unity (OAU) held the second conference. Cote d'Ivoire, Ethiopia, and Zaire all strongly condemned the actions of South Africa as imperialist, and since the OAU opposes colonialism in all forms, South Africa was blacklisted from the Council. Representatives also spoke to a joint solution in which both sides withdraw troops from the contested parallel and place sanctions on both nations in order to ensure that this joint solution is a success. Harsher sanctions for South Africa were alluded to, however, coming from both the OAU and the global community.

THE VOICE OF AMUN

Representative Nino Monea of the Russian Federation is in his third year at AMUN. Monea said that AMUN is a way to improve a variety of skills that include speaking, technical writing, and research. "I really think it teaches you about the international system better than any class possibly can," Monea said. "It's one thing to read how the UN works; it's a whole another thing to experience it firsthand, to see how resolutions are written and how

different countries interact." Monea has a family connection to international affairs.

"My uncle works at American Defense University doing research on the Middle East," Monea said. "He has actually done this work on sanctions and the Arab Spring."

Representative Samantha Taylor of Yemen has been doing Model UN for eight years. This year's conference will be Taylor's last AMUN Conference as a representative.

Throughout her life, Taylor has attended nearly 40 conferences.

"I really enjoy meeting people and discussing current issues," Taylor said. "I've always

been fascinated by foreign affairs. I believe in the United Nations; it's for an idealistic community and I understand that's not everyone's choice."

Taylor said that even though the debates in AMUN are not for real, she can't help but get caught up in the discussions.

"You have clubs like speech team and debate team, but when you're doing the type of simulation you do like in Security Council you really do have to think on your feet for diplomacy and who you want to align with," Taylor said. "I think that makes it so much more interesting."
