Committee & **Council Updates**

GENERAL ASSEMBLY PLENARY Discussion on the first topic, The UN Global Counter-Terrorism Strategy Review, began as Member States attempted to define terrorism in order to better execute a resolution against it. The body requested annual reports from Member States to better monitor terrorism. However, a concern for national sovereignty made this an issue of debate.

GA FIRST COMMITTEE

Monday morning, the General Assembly First Committee continued the discussion of the establishment of a nuclear-weapon-free zone in the Middle East. With seven draft resolutions in total, 1st/I/6, written by Representatives of Iran and Kenya, has received the most support and debate, with four amendments proposed.

GA SECOND COMMITTEE

In the General Assembly Second Committee, the topic changed from Science and technology for development to the topic of the Follow-up to the Conference on the World Financial and Economic Crisis and Its Impact on Development. Currently, the Committee is drafting resolutions and is bringing them to the floor.

GA THIRD COMMITTEE

The intensity has pushed to the next level as representatives have been scurrying to create a resolution that focuses on the rights of the child and specifically education and child sex trafficking. As the day approached the afternoon hours, and excitement about the Representative dance built, the Third Committee worked diligently to pass and combine resolutions.

GA FOURTH COMMITTEE

Anxieties were on the rise in the General Assembly Fourth Committee as American Model United Nations moved closer toward its Closing Plenary session. Even the microphone seemed to be breaking under the pressure.

SCPKO

The representatives on the Special Committee of Peacekeeping Operations are in congruence with their ideas for reports and working apers. The Special Committee on Peacekeeping Operations decided that, through cooperation, what it can accomplish is greater than previous expectations.

DEFINITIONS ARE IM-PORTANT, JUST ASK GA PLEN

Discussion about counter-terrorism began as Member States attempted to create an all-encompassing definition of terrorism.

The first session of the day kicked off with a change of topic from malaria, which had been debated since 23 November 2013, to topic one, the United Nations global counter-terrorism strategy review.

Member States began with a discussion of the United Nations definition of terrorism, calling for a clear distinction between rebel groups and organized terrorist organizations. Discussion on drug and arms trades and their involvement within terrorism was also brought up as a distinction between cartel groups and terrorist organizations.

The General Assembly Concurrent Plenary debated a proposal of annual government reports about individual Member State terrorism, as well as a conflict of national sovereignty in Member States, making such a proposal a difficult thing for Representatives to agree upon. Draft resolution GA/II/3 was still being discussed as the Assembly continued to debate these issues.

However, there are a growing number of Member States wishing to address the second topic, Promoting efforts to eliminate violence against migrants, migrant workers and their families.

THE TRUTH IS OUT THERE, OR PERHAPS JUST IN GA FOURTH

For the first time in 46 years, several Representatives of the General Assembly Fourth Committee have decided to address how the international community should respond to extraterrestrial beings. Representatives from India, Ireland and Lithuania have developed a resolution aimed at the creation of a global apparatus to respond to contact with extraterrestrial events. The resolution has a historical precedent in GA4, with a full year of discussion on the issue in 1977. Representative Clayton Knappenberger of Ireland stressed that

the resolution was not intended to address only the contingency of alien encounters, but any potentially adverse contact with extraterrestrial beings or bodies. Ireland emphasized its earnestness in its pursuit of a broad response system. "We had to let people know that we were serious about this," Representative Drake Yeiter of Ireland said. "It's not just about weapons, but about increasing information sharing and developing technologies to respond to extraterrestrial happenings." Representative Cece Collins of Kenya was skeptical of the resolution's adherence to the purview of the Fourth Committee. "I just don't understand how it's relevant to the peaceful use of space. It's weaponizing space," Collins Representative said. As of the printing of this article, The Fourth Committee had not yet brought the resolution to the floor for debate, but India and Ireland reaffirmed their commitments to bring the resolution before the body to the press. At the time, the resolution had 33 agreed signatories.

Committee & Council Updates, Continued

CCPCJ

The body of the Council on Crime Prevention and Criminal Justice has been hard at work writing and editing two final reports, both of which are projected to be completed by the end of the Monday night session. Representatives also spoke to the progress of these reports in front of the Economic and Social Council in order to keep it abreast of their progress.

Security Council & ICJ Updates

CONTEMPORARY SECURITY COUNCIL The Security Council released a Presidential Statement that urges the Member States that have committed troops to the Mission in the Central African Republic to fulfill these commitments as quickly as possible. The Security Council expressed confidence that the new stabilization measures will be effective once implemented.

HISTORICAL SECURITY COUNCIL '56

In response to the plane crash within the Algerian border on 21 August, 1956 and the alleged involvement of the nationalist rebel group National Liberation Front, the Historical Security Council of 1956 added the Situation in Algeria to its agenda.

HISTORICAL SECURITY COUNCIL '94

After moving forward from the Situation in Bosnia-Herzegovina, the Historic Security Council of 1994 has acted politically in Haiti. However, situations in Georgia and Somalia are getting worse by the day and it is unclear whether or not the Council will have the expediency to address these important issues.

World Affairs Circa 1956

According to resolution HSC1956/II/1, Morocco and Tunisia were admitted to the United Nations on 21 August, 1956.

The congratulatory mood was tainted by the Moroccan government's alleged tie to a nationalist rebel group, the National Liberation Front (NLF). Representative Aaron Thomas of France, who abstained from the voting, expressed his grave concern regarding the admission of Morocco, as he expressed belief the Moroccan government is in support of the rebel group. In response, Representative Michael Pisanti of Morocco commented that France's allegation is highly "insulting" and the Moroccan government "do not support any and all insurgency groups."

The hostile tension between France and Morocco has been aggravated as a plane, which was given to Morocco as aid from the United States and the United Kingdom, crashed in the French colonial territory within Alegria. Reminding the body that aid given to Morocco is mandated to be directly controlled by the Government of Morocco, the Representative of France described the situation as "irritating." He further asserted that, if the plane crash was caused by the NLF and the Government of Morocco is proven to be responsible, France will take immediate action with possible military measures.

The International Court of Justice ruled against Argentina in its case against Uruguay, which concerned the construction of pulp mills on the River Uruguay. The Court determined that Uruguay was in compliance with the standards of a 1975 treaty between the two Member States regarding environmental impacts on the waterway.

Security Council Representatives Sami Ghani and Brendan Moriarty from Argentina discussed a proposed chemical weapons disposal deal. If accepted, Norway would secure safe passage of Syrian chemical weapons to Argentina for disposal.

A leak of the proposal has caused protests by Argentinians who are concerned with the lack of details of how the weapons will be disposed in their country. Despite these fears, the Representatives assured them that they "have taken every precaution" to ensure that the transportation of the weapons will be done safely and that the disposal of them will be done with approved lands and methods.

Nonetheless, there have been growing concerns that the Argentinian government is ignoring its citizens as it forges ahead with this plan.

"The purpose of this commission is to be a report writing commission," said Representative Dana Jackson of Saudi Arabia from the Commission on Crime Prevention and Criminal Justice (CCPCJ).

Jackson said that the lack of work is "appalling" and the commission risks "failure" if report writing is held off for any longer.

The representative is not alone in the CCPCJ as Representatives Gage Meyers of Uruguay and Cody Tracey of the Democratic Republic of the Congo voiced similar concerns over the Commision's priorities.

The CCPCJ is a commission that advises the Economic and Social Council on methods addressing national and transnational crime through report writing. However, representatives are worried about the de-emphasis of report writing by the body in light of the large number of resolutions that have been passed.
