SUBJECT OF RESOLUTION: The Situation in the Central African Republic

SUBMITTED TO: The Security Council

The Security Council,

1 *Applauding* actions previously taken by the African Union and African-led
2 International Support Mission in the Central African Republic (hereafter referred to as
3 MISCA) regarding the situation in the Central African Republic while also noting that
4 further support is needed to ensure further stability in the nation and the successful
5 delivery of humanitarian aid to the citizens of the Central African Republic,
6

7 *Noting* the positioning of the African Union troops in the capital city of Bangui,
8 and hoping to facilitate infrastructure at a local level to create a foundation for local and
9 nation-wide stability
10

11 *Recognizing* the unique situation in the Central African Republic,
12

13 *Stressing* the need to protect the citizens of the Central African Republic and
14 stabilize the situation to allow the citizens of the Central African Republic to complete
15 their obligations under the Transitional Agreement to create their own stable and
16 responsible government,
17

18 *Recognizing* the importance of human rights as laid out by the United Nations
19 Declaration of Human Rights and the potential of both state and non-state forces to
20 violate them,
21

22 *Condemning* the devastation of natural heritage, as stated in resolution 2121
23 (2013), and noting that poaching and trafficking in wildlife are among the factors that
24 fuel the crisis in the Central African Republic,
25

26 1. *Requests* the creation and deployment of Mission In Central African Republic
27 (hereafter referred to as MICAR) to protect the transportation, distribution, and reception
28 of humanitarian aid to civilians and to prevent further humanitarian violations and allow
29 progress in developing local infrastructure, placed along trade routes and rural areas to be
30 determined in collaboration with MISCA and Integrated Peacebuilding Office in the
31 Central African Republic (hereafter referred to as BINUCA);

33 a. MICAR will be comprised of 6,000 armed peacekeeping troops to be donated
34 voluntarily by member states;

35 i. Utilizing the 1,200 already-existing French forces that currently protect French
36 assets and airports in the Central African Republic;

37 ii. Calling for troop donations to aid in the creation of MICAR;

39 b. This mandate expires one year following the deployment of MICAR, unless
40 otherwise renewed by this body;

42 2. *Authorizes* MICAR to conduct necessary operations to secure the safety and
43 stability of the civilian population from being targeted by any group in a capacity outside
44 that of formal law enforcement and to take measures necessary to ensure successful
45 delivery of humanitarian aid;

47 3. *Additionally creates* the United Nations Certification in the Central African
48 Republic comprised of members of the United Nations Human Rights Rapporteurs Office
49 to monitor the human rights situations in the Central African Republic and report back to
50 the Security Council once per year on human rights, the progress of the political process,
51 and the stability of the region.
