#### **Committee & Council Updates GENERAL ASSEMBLY PLENARY**

The final motion of the General Assembly Plenary in its evening session on Sunday brought GA/ II/3 to the floor. Deliberations on the resolution will ensue Monday, 24 November 2014. The resolution boasts signatory support from all five permanent members of the Security Council.

#### **GA FIRST COMMITTEE**

After lengthy deliberations on individual operative clauses of GA 1st/ II/2, co-author Bahrain motioned for an extensive division of the question. Under the division, representatives would have voted for each of the four operative clauses individually. The motion did not pass by an overwhelming majority.

#### **GA SECOND COMMITTEE**

The Second Committee passed Resolution 2nd/I/2 in a 64-34-13 vote. The resolution received more than 38 signatures and was authored by China, Australia, the Dominican Republic and Nigeria. The committee continued debate on proposed Resolution 2nd/I/1.

#### GA THIRD COMMITTEE

The Third Committee voted to move Resolution 3rd/I/3 to the floor. The resolution, which includes 11 policy points, focuses on the intensification of efforts to eliminate all forms of violence against women. The Resolution calls for the creation of an education program to "explain the rights of all genders" to children ages 5 to 10 and a separate program for young adults ages 12 to 18.

#### GA SIXTH COMMITTEE

GA Sixth has come up with three resolutions for Topic II: Criminal accountability of United Nations officials and experts on mission: The focus being transparency. The fourth resolution is in progress.

#### ECOSOC

The United Nations Economic and Social Council has come to a consensus on resolutions ECOSOC/I/1 and ECOSOC/I/2. One will renew and expand the Hyogo Framework for Action (HFA) until 2025 and the other will implement and utilize technological resources to strengthen Member State's capacity to respond to disasters.

# Chile Found Not In Violation of 1896 Treaty

Despite the fact that Chile was not present for the final opinion session, the case of Bolivia v. Chile was decided in favor of Chile. The case was regarding

Chilean government. The Republic of Chile has met its requirements under the designated treaties. The court also ordered that both Bolivia and Chile revisit the Treaty of Commerce, specifically

referring to its vague financial and municipal policies. The court suggested both countries cooperate with trade organizations to maintain current international standards and trade relations.

The Plurinational State of Bolivia filed to institute proceedings against the Republic of Chile on 24 April 2013. Bolivia stated that Chile had an unfulfilled obligation to negotiate with Bolivia regarding a path for sovereign access to the Pacific Ocean.

## HUMAN RIGHTS **EDUCATION PASSES** GA CONCURRENT PLENARY

In a 44-25-31 vote, representatives from Kenya, Madagascar and the Holy See closed debate and passed resolution GA Plen/ II/1 within the General Assembly Plenary. The Plenary's evening session opened with a successful motion of division of the question, separating clause 9 and remaining clauses for individual vote. Operative Clause 9 was struck out quickly with a 13-55-26 vote.

The resolution highlights the implementation of policies in accordance with the Universal Declaration of Human Rights, an expansion of several United Nations and non-governmental organizations that aid conflict zones and proliferation of human rights education. In an interview, Representative Ellen Deweese of Holy See explained how the goals of the Holy See were implemented through the resolution.

"We really want to remind representatives that you cannot effectively fight violence with violence. Military intervention and other force-based measures only create additional conflict," Representative Deweese said. "...This resolution does address the prevention of armed conflict without the use of additional force and/or violence."

#### GA Second Committee

While progress was made Saturday evening in Second Committee as Representatives approved a resolution on entrepreneurs, not all representatives agreed. Representatives voted 64-34-13 to pass Resolution 2nd/I/2 on the topic of Entrepreneurship for Development. The resolution, which was signed by 37 nations, was authored by China, the Congo, Australia, Dominican Republic and Nigeria. The resolution calls for an assessment of a country's resources and then provides training and funding for entrepreneurs in those regions. Representative Curt Allain of China said the process of getting the legislation to the floor to be vot-

involved several countries working after session to write the resolution. "This piece of legislation was a chore," Representative Allain said. "It started off with China [and] myself working hand in hand with the Congo, the African Bloc and Malaysia. The three of us were really trying to come together with the Asian countries that needed development." There was some opposition to the passing of the resolution, he added. "There was a communication breakdown at one point in time and then it seems there were some people that thought they were competing to get a resolution passed," Representative Allain said. Representative Adam Kall of the United Kingdom vot-

though he said he favored most of the points in the legislation. Representative Kall indiated there were two clauses in this resolution of concern; one of them encouraged the forgiveness of bad credit in a speedy manner for small entrepreneurship while the other clause asked for developed countries to forgive the debt of developing countries." More time should have been spent on the resolution, he added. "I would have loved to see this resolution passed in a near perfect state and due to some members feeling the need to push it along, it's now passed in an imperfect state," Representative Kall said.

not please some nations. The Russian Federation expressed discontent with the draft resolution. "[The Russian Federation] felt the resolution lacked strong language and was vague in a number of places," said Representative David Harris. "Specifically, its recommendation to Member States regarding arms trade lacked pertinent details. The draft resolution undercut both domestic courts and state sovereignty through Clause XV on the International Criminal Court and International Court of Justice. These sentiments led to our no vote, and we have no doubt that other nations share these opinions."

#### Committee & Council Updates, Continued UNHCR

The United Nations High Commissioner of Refugees went into a consultative session Sunday evening to discuss new amendments to a draft resolution regarding the sexual abuse of refugees. Representatives discussed amendments to the three-point proposal including a health and safety amendment, an education amendment and a grammatical amendment to the legal framework of the resolution.

### Security Council & ICJ Updates

#### SECURITY COUNCIL

The Security Council continued discussion on the disputed border region of Abyei between Sudan and South Sudan. The Council deliberated the demilitarization of refugee camps and the passing of a potential resolution calling for a referendum on the disputed region.

#### HISTORICAL SECURITY COUNCIL '61

The Historical Security Council of 1961 continued their discussions regarding the remaining Belgian troops in the Congo. The Council hopes to bring about peace talks between the three political leaders of the region.

#### HISTORICAL SECURITY COUNCIL '93

The Historical Security Council of 1993 released a Presidential Statement in response to the Somalia crisis. HSC93 condemned the killing of numerous United Nations peacekeepers, and expressed interest in continuing discussion of possible future action.

#### INTERNATIONAL COURT OF JUSTICE

The International Court of Justice (ICJ) justices presented the opinion for Bolivia v. Chile case at 8:05 p.m. Sunday. The court began consideration of Germany v. United States of America case at 8:15 p.m. Sunday.

On Sunday afternoon, Member States of the United Nations High Commissioner of Refugees reported on the progress of a three-point resolution focused on health and safety, education and the legal framework needed to face issues in the refugee and internally displaced communities. Representative Jimmy Clark of South Africa urged the importance of the Office of Internal Oversight Services to build trust between the sexual health and safety counselors and administration. Representative Clark said this office

mous sexual abuse reporting system. Concerns of a "criminal-like" fingerprint system that would leave refugees further marginalized was met with insight that the committee is currently looking into "less intrusive" options. Assigning women to positions such as sexual abuse counselors and to vocational positions like food production were also discussed. The representatives wanted to offer refugees options when looking for support in cases of sexual abuse as well as offer women vocational skills that would help them transition back to the workforce when they returned home.
