SUBJECT OF RESOLUTION: Assistance in mine action

SUBMITTED TO: The General Assembly Fourth Committee

The General Assembly Fourth Committee,

Deeply alarmed by the dangers presented by the persistence of indiscriminate landmine usage during interstate and intrastate conflict and the compounded hazard that they present in the post-conflict development period,

Noting that previous mine-removal activities by the United Nations Mine Action Service (UNMAS) have been effective at clearing undetonated minefields,

Recognizing the progress achieved in the removal of landmines in actively mined areasas a result of the direct support from 18 current UNMAS programs,

Guided by the infallible value of state sovereignty as the final determinant in all matters pertaining to aid programming and the inclusion of protections for the health and safety of the citizenry as subject to the protections afforded thereto,

10 Understanding the necessity of education to increase awareness about landmines and preventing civilian death,

Having examined The Convention on the Prohibition of The Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on their Destruction, also known as the Ottawa Treaty,

Maintaining a commitment to victims of the tragic casualties caused by landmines,

Declaring that landmines are an outdated, impersonal, uncontrollable technology that must be eradicated,

- 1. Urges the development of educational material to increase public awareness amongst the population of states and non-state actors concerning the consequences of using landmines, in order to:
- 18 (a) Ensure that Member States who decide to use landmines during military operations are held 19 accountable to their people, and that said people are fully aware of the long term consequences of their government's 20 actions, including;
 - (i) Limiting the possible uses of land that is marred by mines;
 - (ii) Injuring and killing civilians long after conflicts end;
- 23 (b) Reduce the number of state and non-state actors willing to place and use landmines during 24 conflict;
- (c) Improve the quality of life of the population that currently inhabits landmine-stricken territories, in particular by;
 - (i) Creating regional workshops in partnership with UNMAS to focus on communities that suffer from loss of land to active minefields:
 - (ii) Providing best practices to ensure that landmines are not accidentally triggered;
- 30 (iii) Instructing land workers on techniques to ensure the safety and long term sustainability of cultivation on formerly landmine-stricken fields;
 - (iv) Supporting landowners in seeking reparations for the decrease invalue of the arable land that they formerly possessed;
 - (d) Understand the potential shifts in landmine locations over time and the dangers posed as such;

- 2. Recommends the expansion of currently implemented mine assistance locations beyond the current 18under the purview of the United Nations Office of the Coordinator for Mine Action, in order to:
- 37 (a) Support the development of infrasctructure that will allow for civilian victims of mine detonation 38 to access health care facilities in areas not currently serviced;
- 39 (b) Collect a comprehensive data set documenting the number, needs, situations, and location of 40 mine victims;
- 3. Proposes the creation of a central repository for all mine-related treaties, conventions, and resolutions, in order to create a more effective political tool by organising Member States' positions on landmines as reflected in the treaties, conventions, and resolutions that they have ratified;
 - 4. Encourages the development of stronger relationships between the United Nations Development Program Partnership for the Future and Non Government Organizations in order to facilitate landmine-removal and land-reclamation projects funded by the two organisations;
- 5. Suggests the precedent of 'mine for mine' disarmament, between states that have historically been in conflict, and in particular, states with direct border conflicts;
 - 6. Calls for the creation of a new subcommittee within UNMAS in collaboration with the United Nations Institute for Disarmament Research (UNIDR) for the purpose of developing international relations pertaining to the sharing of technology as it relates to disarmament, in particular by modeling from partnerships between states that provide different parts of the same solution to disarmament.
