# SECURITY COUNCIL Renews Investiga-TORY MANDATE ON CHLORINE GAS Use in Syria

The Security Council has extended, for an additional year, the mandate of the United Nations-Organization for the Prohibition of Chemical Weapons (OPCW) Joint Investigative Mechanism, the body tasked with identifying those behind chemical weapons attacks in the Syrian conflict.

Unanimously adopting Resolution 2319 (2016) earlier this week, the Council also recalled its decision that Syria "shall not use, develop, produce, otherwise acquire, stockpile or retain chemical weapons, or, transfer, directly or indirectly, chemical weapons to other States or non-State actors."

Further in the resolution, the Security Council encouraged the Mechanism to engage with relevant regional States in pursuit of its mandate, including to identify any involvement of the Islamic State of Iraq and the Levant (ISIL) the Al-Nusra Front or other non-State actors in the use of chemicals as weapons in Syria.

Set up in August of 2015, the Mechanism was mandated to identify, to the greatest extent feasible, those involved in the use of toxic chemicals as weapons in Syria.

Western powers want the Security Council to impose sanctions on the Syrian government for using chemical weapons. But Russia, Syria's closest ally, has repeatedly questioned investigators' conclusions linking chemical weapons use to the egime of President Bashar Ass

Syria has repeatedly denied its forces used chemical weapons, despite investigators for the most recent OPCW report having determined that the Syrian government was behind at least three attacks involving chlorine gas. Damascus rejected these claims, with the Syrian Foreign Ministry stating that they "regret the decision made by executive council of OPCW concerning Syria at a vote that was beyond the scope of the organization's responsibilities and that demonstrated the schism tendency among the member states." The Syrian government has not made a public statement regarding the renewal of the OPCW Joint Investigative Mechanism mandate.

# Staying in your Lane - Understanding Purview

AMUN prides itself on simulating the United Nations' proceedings in the "real world." To facilitate this, AMUN staff members are trained to review draft resolutions to make certain they are within purview.

Purview defines the scope of a topic that each committee, council or commission can address. Thus, even if two or more committees are discussing a general topic, each committee is made responsible for discussing a very specific point or aspect of that topic.

For example, if the general topic

under discussion is conflict in Sub-Saharan Africa, the GA Plenary may discuss the topic as a whole, but the main committees would focus on specific aspects. The First Committee—which focuses on security issues-might discuss how reducing illicit trafficking in firearms can support development, while the Third Committeewhich addresses social, humanitarian and cultural issues-might focus on how preventing hunger or supporting education can achieve the same outcome. Each committee (and the Representatives therein) should be quite careful not to expand the discussion

of any topic beyond its mandate. AMUN dais staff will review resolutions to ensure they are focused and within the scope of the committee's, council's or commission's ability to address a particular topic. If Representatives have any in-depth questions about purview, they should start with the Issues at AMUN handbook. If questions remain, they should speak with their Rapporteurs, who can be found in the committee rooms. These staff members are trained to help representatives ensure their draft resolutions are within the purview of their committee,

council or commission to discuss.

# SAFETY AT AMUN AND IN CHICAGO

To ensure that everyone in your group, including Faculty Advisors and Permanent Representatives, is able to focus on the experience, we have some simple suggestions for your own safety and that of everyone in your group at AMUN.

As a starting point, I encourage you to review the Safety at AMUN information on page 37 of the Conference Program. These suggestions should be the starting point when you are considering your safety and that of the people around you.

#### STAY HYDRATED

Large conference hotels are notoriously arid. You may feel as if you have trekked across a desert by the time the Conference closes. You will need to drink significantly more water than normal to stay hydrated. Be careful with dehydrating drinks. Consumption of beverages such as coffee, soft drinks, energy drinks and alcohol may have a dehydrating affect. Drinking these, especially more than you typically would,

will contribute to the problem. In the past we have seen many Representatives get sick as a result of dehydration. Increase your water intake and reduce your consumption of other beverages to stay healthy.

#### THEFT

Enterprising thieves will dress up in suits in order to blend in with the crowd at large conferences. They can quickly sweep through a room and snag phones, purses, laptops and other valuables. Be aware of people who are not wearing AMUN Conference credentials and immediately report them to a member of the AMUN Secretariat.

#### GENERAL SAFETY

Always be sure that someone from your group knows where you are, and use the buddy system when leaving the hotel, especially at night.

## What are Rapporteurs and What Do They Do?

Walk into any of the General Assembly Committees or Economic and Social Council commissions, and you will immediately see Chairs and Vice Chairs, or Presidents and Vice Presidents, sitting in front of the room, usually with a microphone, presiding over the body. But who are those staffers with the blue badges sitting off to the side? And why are they wandering around the room, listening to all of your caucusing?

Well, distinguished representatives, they are your Rapporteurs! If you are an AMUN veteran, you may remember this as the place where you take all of your resolutions and amendments for approval and processing. Indeed, that is a Rapporteurs examine every draft report, resolution and amendment to ensure that it is within purview (see article, page 1); in proper AMUN format; and is clear, cohesive and free of grammatical error.

They may ask you to make corrections to your draft (which is why they always ask you for two copies of anything they are editing) to ensure all of the documents that come before the body are of the highest possible quality. They also keep track of all of the documents, so if you need to know the status of any draft, your Rapporteurs will be more than happy to share that information.

But the Rapporteur Department does much more than manage paperwork. Often, you will see Rapporteurs circulating during suspensions, listening in on informal debate. Because so much session, staff should be available to assist there as well. Specifically, Rapporteurs may clarify a procedural issue, suggest an alternate perspective, or suggest a possible roleplayer who might be helpful. They may point out additional collaborative partners based on drafts they have edited or conversations they have heard. They also know a thing or two about the rules, specifically as they relate to reports, resolutions and amendments.

Essentially, if you find yourself having any conversations that begin with "I wonder if...," or "maybe we could...," seek out a Rapporteur, who will help you make sure that you are on the right track. They can answer most questions, and if you happen to come up with something that they can not answer, they will be more than happy to point you in major function of this department. work gets done outside of formal the direction of someone who can.
