SUBJECT OF RESOLUTION: The Situation in Yemen

SUBMITTED TO:

The Security Council

The Security Council,

1 *Recognizing* the importance of the safety and security of the people of Yemen,

2 Reaffirming the contributions towards an improvement in the situation of human rights, and encouragement 3 for all parties to reach a comprehensive agreement to end the conflict as stated in Security Council Resolution 2216 4 (2015),

5 *Acknowledging* the global investment in Yemen's humanitarian crisis,

6 *Recalling* the critical situation in the Port of Hodeidah and its importance in delivering aid to Yemen, as 7 outlined by Security Council letter S/2018/675,

8 Seeking a peaceful, united Yemen state in the near future,

9 1. Demands for a peaceful ceasefire in the proposed port city Hodeidah, as determined by the respective 10 parties of the Yemeni Government, led by Ali Abdullah Saleh, and the Houthi movement, advocating for this location 11 to be at the Port of Hodeidah:

(a) Peace will be called for the duration of two months after aid is fully procured;

(b) The Security Council will revisit this port in two months;

14 2. Affirms humanitarian aid will include food and chlorine-based water purification supplies:

(a) Such aid will only be delivered through the designated ceasefire zone to the respective parties
upon adherence to the ceasefire agreement;

(b) Peace talks must be held within three months after passage of this resolution and the implemen tation of this ceasefire agreement;

(c) Funding distribution will be determined by United Nations International Children's Emergency
Fund (UNICEF), with the potential for incremental increases up to an amount determined by UNICEF;

21 (d) Funding will be derived from the United Nations Yemen Humanitarian Response Plan to imple-22 mented into action;

3. *Authorizes* the creation of a committee within UNICEF to oversee and advise humanitarian aid delivery if all parties involved return to peace consultations, with the duties of the committee being:

- (a) To encourage the peaceful and efficient administration of aid;
- (b) To continue aid in the same amount in cycles of two months;

(c) The delivery of aid dispersion throughout Yemen will be assisted by local Non-governmental
Organizations, such as the active International Rescue Committee and World Food Program Collation, in tandem
with UNICEF and all involved parties;

4. Proclaims continuation of aid will be revisited by both the Security Council and negotiation representa tives:

32 (a) Negotiations will reinforce that aid will be halted if used for military purposes, actions, or 33 attempts to control the internal population of Yemen;

- 34 (b) If the designated UNICEF regulation committee reports that involved parties are utilizing the
- 35 time aid is being administered to develop their military power and transfer of weapons, aid will discontinue and the
- 36 Security Council will impose necessary sanctions and employ peacekeepers as we see fit.
